OPINION BY ADMINISTRATIVE JUDGE ELMORE ON THE GOVERNMENT'S MOTION FOR RECONSIDERATION

The Board on 19 January 2000 issued its decision denying the parties' cross motions for summary judgment. On 27 January 2000 the Government filed a Motion for Reconsideration of the Board's decision on the Government's Summary Judgment motion. In response, appellant filed a series of affidavits. Familiarity with the Board's original decision is presumed.

In its reconsideration motion the Government argues that appellant has failed to put forth any evidence, in the form of affidavits or other sworn statements, supporting its contention that the existence of the asbestos-wrapped pipe in the living room wall to be demolished was not reasonably foreseeable and, accordingly, that appellant cannot make out a *prima facia* case.

Appellant responded to the Government's motion for reconsideration and has proffered six affidavits^{*} which we determine, upon review, offer sufficient evidence to support appellant's arguments that it relied on the contract documents which did not detail the asbestos-wrapped pipes in the living room walls. Further, appellant's evidence

indicates that the existence of the asbestos-wrapped pipes in the living room walls was not reasonably foreseeable.

We have reviewed the Government's reconsideration motion and cannot find any compelling reason to disturb the original decision. Accordingly, the Board's original decision is affirmed.

The Government's motion for reconsideration is denied.
