SUBJECT: REPORT OF TRANSACTIONS AND PROCEEDINGS OF THE ARMED SERVICES BOARD OF CONTRACT APPEALS FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2024

This report is furnished under paragraph 9 of the Charter of the Armed Services Board of Contract Appeals, revised May 23, 2019. The statistics reflect the adjudication of appeals, petitions for contracting officer final decisions, applications for fees and costs under the Equal Access to Justice Act, and other matters of the Army, Navy, Air Force, Corps of Engineers, Defense Logistics Agency, Defense Contract Management Agency, other Defense agencies, Central Intelligence Agency, National Aeronautics and Space Administration, and the Washington Metropolitan Area Transit Authority.

In FY2024, the Board disposed of 126 cases on the merits. Of those dispositions, 46% of the decisions found merit in whole or in part. The Board dismissed 293 cases. In the majority of cases, a dismissal reflects that the parties have reached settlement.

4. During FY2024, the Board held 15 hearings, for a total of 83 days, adjudicating 34 cases.

E. Board Decisions Appealed to the U.S. Court of Appeals for the Federal Circuit (CAFC)

In FY2024, the U.S. Court of Appeals for the Federal Circuit (CAFC) docketed 13 cases from Board decisions and had 19 cases pending at the close of the fiscal year. During FY2024, the CAFC disposed of 9 cases involving ASBCA decisions, 7 of which were affirmed, 1 of which was affirmed in part and vacated and remanded in part, and 1 of which was dismissed.

F. Alternative Dispute Resolution (ADR) During FY2024

97 cases (including 5 off-docket matters) were voluntarily diverted from the regular trial docket to the Board's ADR program. 10 of these cases were settled, with the assistance of the mediator judge, without requiring formal mediation sessions. 5 were withdrawn. The remaining 82 were addressed in 35 ADR sessions, totaling 71 days. 67 of these cases were successfully resolved, 0 were unsuccessful, leaving 15 pending at the close of the fiscal year. An additional 14 cases are pending ADR sessions in FY 2025.
